

## Driving Directions

### Superior Street Construction

April 2019 - October 2019

Beginning on April 8<sup>th</sup> through the middle of October a portion of Superior Street in front our building will be closed for construction. To ease your travels to our office here are some directions to the parking ramp behind our building. If you have any questions or issue finding the ramp please call us at 218-336-2500.

#### Traveling North to Duluth (Driving North on I-35):

Follow I-35N to right Exit 256B for 5<sup>th</sup> Ave W. Continue through the first stop light and follow signs for Lake Ave. At second stop light turn left onto Lake Ave. Continue onto Lake Ave for three blocks until E. 2<sup>nd</sup> St, turn right onto E. 2<sup>nd</sup> St. Follow E. 2<sup>nd</sup> St for one block and turn right onto 1<sup>st</sup> Ave E. Continue down 1<sup>st</sup> Ave E. one block and turn right on E. 1<sup>st</sup> St. and enter parking ramp from left lane.

#### Traveling from Mall Area:

Follow E. Central Entrance until the Mesaba Ave intersection. As you approach the Mesaba Ave intersection take right exit for Mesaba Ave. At the first stop light turn left onto W. 7<sup>th</sup> St for one block and turn right onto Lake Ave. Continue down Lake Ave till E. 2<sup>nd</sup> St and turn left onto E. 2<sup>nd</sup> St. Follow E. 2<sup>nd</sup> St for one block and turn right onto 1<sup>st</sup> Ave E. Continue down 1<sup>st</sup> Ave E. one block and turn right on E. 1<sup>st</sup> St. and enter parking ramp from left lane.

#### Traveling South to Duluth (Driving South on I-35):

Continue on I-35S until you approach the first exit for Lake Ave Exit 256B. Take Exit 256B and stay in the left lane towards Lake Ave. At stoplight turn right onto Lake Ave. Continue onto Lake Ave for three blocks until E. 2<sup>nd</sup> St, turn right onto E. 2<sup>nd</sup> St. Follow E. 2<sup>nd</sup> St for one block and turn right onto 1<sup>st</sup> Ave E. Continue down 1<sup>st</sup> Ave E. one block and turn right on E. 1<sup>st</sup> St. and enter parking ramp from left lane.
